Below are some details pertaining to the various categories of membership available at Massey Park Golf Club. Please note that if you are wishing to join in any of the golfing categories a waiting period may exist.

If wishing to join as a Social Member, which has no golfing rights you can post or drop in your application form with the entry fee at any stage throughout the year.

BENEFITS OF MEMBERSHIP

Membership to our Golf Club has many benefits such as discount on green fees and selected items in the Pro-shop as well as a discount on drinks in the clubhouse* and eligibility to win in house promotions such as Member's Badge Draws. Golfing membership also provides access to the golf course during prime booking times, eligibility to participate in organised golf events including representative golf. National management of handicaps is through Golfink. Golfing members also are entitled to additional use of clubhouse facilities such as showers, secure locker and storage rooms.

Social membership allows you to use the Clubs facilities. It also allows you to partake in our Wednesday Night Badge Draw and Friday Night Badge Draw. It also entitles you to receive drinks at member's prices* and participate in any promotion undertaken by the club. * **Not applicable to functions unless a financial member of the club for a minimum period of 12 months.**

Our membership year runs as per the Financial Year - July to June, all fees are due to be paid prior to the end of the Financial Year otherwise all membership rites will be cancelled.

If you are wishing to join as a Golfing member please note the various categories listed below:

GOLF MEMBERSHIP

- **JOINING FEE:** The Joining Fee is a *once only* fee paid when joining the club and is subject to change during promotions.
- **BAR ACCOUNT:** The Bar Account component of the annual membership fees is applicable to eligible golfing categories. This amount is credited the membership account and can be redeemed within that membership period by having your membership card swiped by bar staff when making a purchase at the bar. Members will receive a receipt for their purchase and the receipt will provide details of the sale and the balance remaining in their account.
